(Processing may take 5 to 10 days.)

I hereby agree to the following conditions:

1. No line is to be covered until inspected and approved by a Borough Representative. Scheduling must be done 24 hours in advance.
2. The service line shall be installed according to the attached sketch of a typical sanitary sewer service line.
3. All joints shall be tightly fitted to prevent infiltration.
4. Backfill to be sand or stone, no larger than No. 2.
5. No trash to be put in ditch with line.
6. All public water and private wells to be metered.
7. No surface water to enter sanitary sewer lines, including garage drains, french drains, down spouts, etc.
8. The initial inspection cost is included with the Tap-In Fee. Additional inspections will cost \$55 each.
9. A trench box is required for tap connections deeper than five (5) feet.

"The undersigned hereby certifies that the information contained herein is true and correct and that the information supplied to the Borough is relied upon in determining the type, location and fee for all taps and should any of the information prove false, the Borough may relocate the tap, change the type of tap or increase the tap fee in accordance with the facts that actually exist".
