The public meeting of the Borough Council of Connoquenessing was called to order.

SEWAGE PLANT UPDATE

Dave Bocci gave the monthly update. The Plant is an 80,000 gal. plant, Average flow for June 24,000, High 32,000. Pump Station to be turned over to the Borough is still pending. Fence has not been installed.

Jeff Kroner spoke of the increase fire mill in taxes. Jeff stated that his Homeowners Insurance would increase more than the new tax costs. He believes that the new Mill rate should pass. He also wondered if paving the parking lot is the best use of the Borough’s money.

Connoquenessing Fire Department made an Official Fire Tax Request (average \$18.00) 1 Mill Increase. Spear motioned to increase millage in 2025 Martin seconded, Motion passed.
