

# **CONNOQUENESSING BOROUGH COUNCIL MEETING**

June 7, 2022

The public meeting of the Borough Council of Connoquenessing was called to order.

Present were Council members Lloyd Leslie, Chris Logan, Rob Campbell, and Francis Smith.

Also present were Dave Bocci, Nathan Leslie, Bob Martin, Dennis Fallon, Janet Marburger, Jeffrey Zbezinski, and Vickie Forbes.

Nathan Leslie from Troop 19 stated that he was attending the meeting to record part of the meeting as part of a Community Service Merit Badge project.

Bob Martin stated that he would like to have the speed limit on Rt. 68 lowered.

Dennis Fallon stated that Rt. 68 was in need of major repairs which also presented safety issues.

Janet Marburger stated that Shelton Place Drive needed regular cleaning due to the mud and rocks left by contractors. Council indicated that another contact would be made with the developer.

A request by Betz to petition the State to reduce the speed limit on Rt. 68 was reviewed. Council agreed to support his going to neighboring municipalities to promote this issue. Council agreed that for safety concerns, the discussion should include creating a turning lane.

Smith motioned, Campbell seconded to approve Resolution 2022-05 Disposition of Records. Motion passed.
