

# CONNOQUENESSING BOROUGH COUNCIL MEETING

March 1, 2022

The public meeting of the Borough Council of Connoquenessing was called to order.

Present were Council members Lloyd Leslie, Chris Logan, Rob Campbell, Francis Smith, David Hilliard, and Mayor Ray Betz.

Also present were Dave Bocci, Denny Frost, Paul Maranchi, and Vickie Forbes.

Denny Frost, 145 Shelton Place, expressed concern regarding the unsafe issue due to the lack of stop signs on Shelton Place Drive and Essex Court. Campbell motioned, Hilliard seconded to request the Borough Engineer look at the street layout and prepare to make comments regarding street signs at this location and for Phase 2 at the April meeting. Motion passed.

## SEWAGE PLANT UPDATE

Bocci provided comments on the annual Chapter 94 report and reviewed charts related to hydraulic flows for 2021 and the projected monthly averages through 2026. Hilliard motioned, Smith seconded to approve and sign the Chapter 94 Municipal Wasteload Management Report. Motion passed.

Campbell motioned, Hilliard seconded to move forward with this option and to adopt Resolution 2022-04 – Connoquenessing Playground Equipment. Motion passed.
