OLD BUSINESS:

State Workers Insurance Compensation (SWIF)

Final results of the dispute concerning the 2016 audit have not been received. An executive decision was made on 12/28/17 to switch workers comp coverage on Borough employees to Selective and to create a policy with SWIF covering the Fire Department. Action was required on 12/28/17 to avoid any lapse in coverage for FD members. Even though the WC rates are lower with Selective for Borough employees, an increase in premium of approximately \$125 will be realized by the Borough due to a minimum premium requirement.

Revised Phase 3 Planning Module Components-Resolution 2018-02

Submitted forms were reviewed by the Borough Engineer and approved for signatures. Reed motioned, Leech seconded to adopt Resolution 2018-02 and to sign the planning module forms. Motion passed.

Leslie read a resignation letter from Carol Kaufman, Tax Collector. Hilliard motioned, Leech seconded to accept the resignation. Motion passed. Council requested action be taken to have Borough real estate taxes collected by Butler County. Contacts will be made with the Solicitor and Butler County.

NEW BUSINESS:

PA Department of Conservation and Natural Resources - Grant

A letter from the PA DCNR stating that the Borough was awarded a \$40,000 grant was reviewed and discussed.

Municipal Code Association

Council reviewed a request by the MCA to handle building inspections for the Borough and discussed their fee schedule and how those fees applied to an existing building permit application. Council elected to make no changes to the building inspections.

The Fee Schedule was reviewed. Leech motioned, Smith seconded to adopt Fee Resolution 2018-01. Motion passed.

Council reviewed. Audit to begin January 15, 2018.

Gannett Fleming was approved as Borough Engineer with appointments.

2018 Community Development Block Grant Program

Council discussed the objective of the grant program and determined that the Borough could not meet the low-moderate income requirement to be eligible for funding.
